## **PUBLIC PARTICIPATION:**

Beverly asked if the Councillors had any questions about the Summer Event on the 22<sup>nd</sup> June. Cllr Bush asked if there's anything left to decide or order, Beverly said it's all in hand. Cllr Aspray queried the cost to the council. It was confirmed that at present it is within budget.

Both Cllr Aspray and Cllr Ong offered to stand for chair so, along with Beverly Ong, they were asked to leave the room whilst Councillor's voted.

It was **RESOLVED** and agreed that Cllr Aspray is nominated for Chair.

**9. To receive and consider a report on the current uptake, waiting list and upkeep of the allotments (for purposes of report only). Appendix 4.**

The report was received.

**10. To consider a report on Parish Council Working Groups and alignment against budget. Projects and Working Groups 2024-25—For discussion - Appendix 5.**

Cllr Bush explained the costings for the working groups and asked if anyone has any thoughts. Cllr's Bush and Ong disagreed about whether anything under £1000 should be a fixed asset. Cllr Aspray suggested they arrange to meet to discuss this further.

**Action: Cllr's Bush and Ong agreed to meet and will report back to F&GP in July with their outcome.**

**11. To confirm and approve signatories against each of the Parish Council's bank accounts.**

Ideally there should be four signatories so it was suggested to add Cllr Aspray and Cllr Ong as well as the Parish Clerk.

It was **RESOLVED** to accept and approve four signatories plus the Parish Clerk.

**Action: Parish Clerk to investigate process to add signatories and to standardise mandates.**

Cllr Korenevsky left the meeting at 8pm.

**12. To receive and note the AGAR 31/03/2024 Internal Audit report signoff by the Internal Auditor, Rosie Darkin-Miller; and to receive and consider Mrs Darkin Miller's report and recommendations to the Parish Council on matters identified during the internal audit process. Appendix 6.**

Cllr Bush reported that the main issue was to do with contracts. Councillors are confident that it was an isolated incidence which has been rectified so are happy to make a recommendation to Full Council to accept the report.

It was **RESOLVED** to make a recommendation to Full Council to accept the report.

**13. Members to each confirm that they have no conflict of interest with BDO, the appointed external auditors.**

It was confirmed that there are no conflicts of interest with BDO and the form has been signed accordingly.

Due to incorrect figures the report was referred to the June Full Council meeting for consideration.

**17. To consider Planning Application P/HOU/2024/02863 11 Old Pound Close, Lytchett Matravers, BH16 6BW. Single Storey rear extension.**

It was **RESOLVED** and agreed that the Parish Council has no objection to this planning application.

**18. To consider Planning Application P/FUL/2022/01134 74 High Street, Lytchett Matravers. Change of use of outbuilding to a mixed use comprising incidental residential use and use for a maximum number of 195 nights per calendar year for letting.**

It was **RESOLVED** and agreed that the Parish Council has no objection to this planning application.

Councillors are concerned about access from the High Street. In 2021 the residents asked for pedestrian access which was granted. Cllr Aspray would like to know how long this permit lasts.

**Action: Clerk to look for correspondence relating to this.**

**19. To consider any arrangements for the summer events.**

Cllr Abbott is meeting with Beverly on the 14.6.24 to make any final arrangements

**20. To consider any items for an article in the next Parish Magazine.**

Entries to be received by the 15<sup>th</sup> June. Magazine is distributed on the 30<sup>th</sup> June.

Councillors asked Cllr Bush to consider including the following:-

- Guerilla Gardeners – recognition of the great work carried out opposite Methodist church.
- Path in cemetery.
- New parish clerk announcement.
- Damage to tree –Councillors asked if we can say the damage was noted and efforts have been made to protect the tree.
- After many delays the steel framework has finally arrived so work can progress.
- Councillor vacancies.
- Finger posts – sponsorship? Adopt a fingerpost?
- Volunteers for the Neighbourhood Plan.

**21. To note correspondence received.**

- Cllr Huggins investigated the cost of replacing the netball net (£10) although is not sure which net this is. **Action: Clerk to confirm with the caretaker and report back to Cllr Huggins. Post meeting note: Cllr Huggins informed it is the basketball net.**
- Cllr Huggins reported the post on FB regarding damage to the zip line. Sutcliffe Play have quoted to repair the zip line and replace the stop, also repair to trampoline (replacement of five springs).

It was **RESOLVED** and agreed to accept the quote and ask Sutcliffe Play to carry out the

work ASAP.

- Cllr Abbott reported the overgrown hedge in the field by Glebe and that the public are having to walk on to the road to get past so is causing a health & safety issue.  
**Action: The Clerk will email Sandra Palmer to request that the hedge is cut according to guidelines provided by Dorset Council Highways.**
- Cllr Bush reminded Councillors that the Annual meeting is on Saturday from 10am-12.
- Cllr Ong was happy to report that residents have congratulated the Parish Council on their speed in getting the dog area grass cut.
- Cllr Ong attended the St Mary's church cream tea and the Vicar asked when the bench is going to be moved. Transport is an issue as the bench is heavy and Cllr Webb said he will see if he can help. Cllr Bush and Cllr Morgan will prepare (slab) the area where the bench will be situated.
- Cllr Ong queried if a response had been received from Dorset Council regarding the £15 rent bill - a claim and payment had been incorrectly made in 2023/24 financial year
